Terms and Conditions

- **1.** By participating in Baxi's Oxford United Season Ticket Holder Exclusive Cashback Promotion, you fully agree and accept these Terms and Conditions.

3. Eligibility

- 3.1. This promotion is open exclusively to Oxford United Football Club Season Ticket holders. The season ticket must be valid for the 2025/26 football season.
- 3.2. To participate, individuals must:

7. Coupon Code and Claims Process
